**SUPPLEMENTAL NARRATIVE:****Name:** MJ THOMPSON**Date:** 01:57:07 10/23/15

On October 22, 2015 at 1908 hours I responded to 627 N Main St on the report of several subjects fighting.

Upon my arrival, I observed two adult females assaulting each other. I attempted to separate the two females. Both continued to fight after I ordered them several times to stop. Once the females were separated, I advised the first one to place her hands behind her back. She actively resisted my request. I took her into an escort position and placed her onto the ground where myself and Officer Lash applied handcuffs. She was stood up and placed into Officer Lash's patrol car. I spoke with this female, who identified herself as ██████████. ██████████ stated that her and her girlfriend, ██████████ were fighting over issues they were having with their relationship. She stated that they began to fight inside of the residence but her mother made them go outside. ██████████ stated that she did not wish to press charges and did not required a squad at this time.

I then spoke with ██████████. ██████████ stated that she and her girlfriend ██████████ got into an argument and that they then began to fight. She stated that she did not wis provide a statement and did not want charges pursued. I asked ██████████ what caused this and she stated they were just having issues in their relationship.

During the course of this, a juvenile male who identified himself as ██████████ continued to shout profanity towards myself and ██████████. I advised ██████████ he needed to go inside his residence considering he did not have anything to do with this and he replied "fuck you." ██████████ continued to be aggressive towards officers. I advised ██████████ to turn around and place his hands behind his back. ██████████ initially did not comply with my request. Eventually ██████████ allowed me to place him into handcuffs. Kent's handcuffs were double locked and checked for tightness. ██████████ was then placed in the back of Officer Marrs' cruiser.

██████████ was advised he was being cited for ORC 2917.11A2; Disorderly Conduct , a fourth degree misdemeanor and was advised he would be contacted by Juvenile Court with a court date.

██████████ was advised she was being cited for ORC 2917.11(A)(1); Disorderly Conduct, a minor misdemeanor and was advised of her court date in Miami County Municipal Court for November 4, 2015 at 0900 hours.

**SUPPLEMENTAL NARRATIVE:****Name:** M L LASH**Date:** 02:33:36 10/23/15

On 10/22/2015 at approximately 1908 hours Officer Thompson and I responded to 627 North Main Street on a report of a disturbance.

Officer Thompson arrived on scene first and advised me to respond to the back of the residence. Upon arrival I located Officer Thompson in the Ary's Auto car lot. I observed Officer Thompson trying to put a female, later identified as [REDACTED], into handcuffs. At this point Officer Thompson already had [REDACTED] lying on the ground on her stomach with her hands behind her back. I helped Officer Thompson place [REDACTED] in handcuffs. I checked the cuffs for proper fit, double locked them, and placed [REDACTED] into the back of my cruiser.

After I placed [REDACTED] into my patrol car I spoke to [REDACTED], [REDACTED], and [REDACTED] [REDACTED], who were also standing in the parking lot. [REDACTED] was obviously upset and Officer Thompson advised she had been the other female that [REDACTED] had been fighting with when he arrived. I spoke to [REDACTED] and [REDACTED] who advised the two female had been physically fighting inside the residence until they were asked to go outside. [REDACTED] advised the females then came outside and began to physically fight again. He advised he and [REDACTED] were trying to break up [REDACTED] and [REDACTED] from fighting when Officer Thompson arrived.

I tried to speak to [REDACTED] who advised she was too upset to talk to me just yet. I advised her to stay seated on the ground until Officer Thompson could talk to her.

I spoke to [REDACTED] who advised she and [REDACTED] had been physically fighting because of an argument they had had about their relationship. I spoke to Officer Thompson who advised he was going to charge [REDACTED] and another male who was also on scene with disorderly conduct. I advised him I would be charging [REDACTED] with Disorderly conduct as well. I advised [REDACTED] of her citation, she advised she understood and advised she would be leaving with [REDACTED] to go to Sidney, Ohio for the evening.

I issued [REDACTED] misdemeanor citation number 78470 for Disorderly Conduct, ORD 132.04(A)(1). While I was issuing [REDACTED] citation she advised her hand was hurting and requested a squad. [REDACTED] advised her hand was hurting from punching [REDACTED]. I removed [REDACTED] handcuffs. [REDACTED] had no visible injuries on her hands. The Piqua Fire department responded but [REDACTED] signed a refusal for medical treatment form. [REDACTED] was released from the scene.
