On 04/26/15 at 1728 hours, I was dispatched to 312 W Grant St. for a menacing complaint.

Upon arrival I spoke with . Brandy advised her daughter, was on Adams St. near the intersection of W Grant St., when approached her and told her he was the devil. Patrick then allegedly stated he was going to hurt her, which caused her to ride her bike home. described as being panicked and very frightened.

I responded to the area of home a S Downing St., Apt. 4. I got out and made contact with . was highly intoxicated, slurring his words and not making a lot of sense. stated he never talked to any girl, but did admit to being in the area. stated he came from South and Adams St, taking Adams St. almost the whole way home, walking past the location of the complaint. Patrick also stated he just got home 15 minutes ago, making him be in the location at the place and time the alleged threats occurred. still denied making the threats.

I warned or disorderly conduct, and he then became angry. told me to leave his property, and I began to. then walked up behind me, almost bumping into me, as I was about to go down his steps. I pushed P in the chest with my left hand, pushing him away from me, as I thought he was going to assault me. stumbled and fell into the house. I advised he was under arrest and not to move. k then took a fighter's stance, putting his hands up as if he was going to attempt to hit me. then attempted to get something out of his left pants pocket. Knowing he usually carried a knife, I advised him to remove his hand or he would get tased. Remembering he had serious complications from a previous taser incident, I waited till he removed his hand, and saw that he had nothing. I told him again that he was under arrest, telling him to get down and put his hands behind his back. refused so I went to grab his arm and he attempted to punch me with his other. then tried to go into his residence, so I grabbed him by the belt, pulled him out of the front door area and took him to the ground in the grass, south of his front porch.

While on the ground, was attempting to lay on his arms, and kept attempted to get up. I held down, with my leg across his lower body and belt line, and hold him down with my arm across his shoulders. I was able to gain control of both of his arms when , had pulled up and got out to assist me. Patrick was still trying to pull his arms away, so applied pressure to his upper body to hold him down, as I handcuffed him. Officer Fogt and Officer Beasley then arrived on scene.

While was one the ground I searched him. I located a small pipe that smelled like marijuana, which was later entered into evidence, in a small pouch with chewing tobacco. There was also a very small pocket knife in the front left pocket of his jeans. The knife was left inside the residence, which was secured by Officer Beasley at the request of . The whole time was on the ground, he stated I was done and that he will see me again. then stated all of this because he said he was the devil, and admitted to telling everyone he is the devil. was then helped up and walked to the back of my cruiser. was also attempting to kick me, so Officer Beasley and Officer
